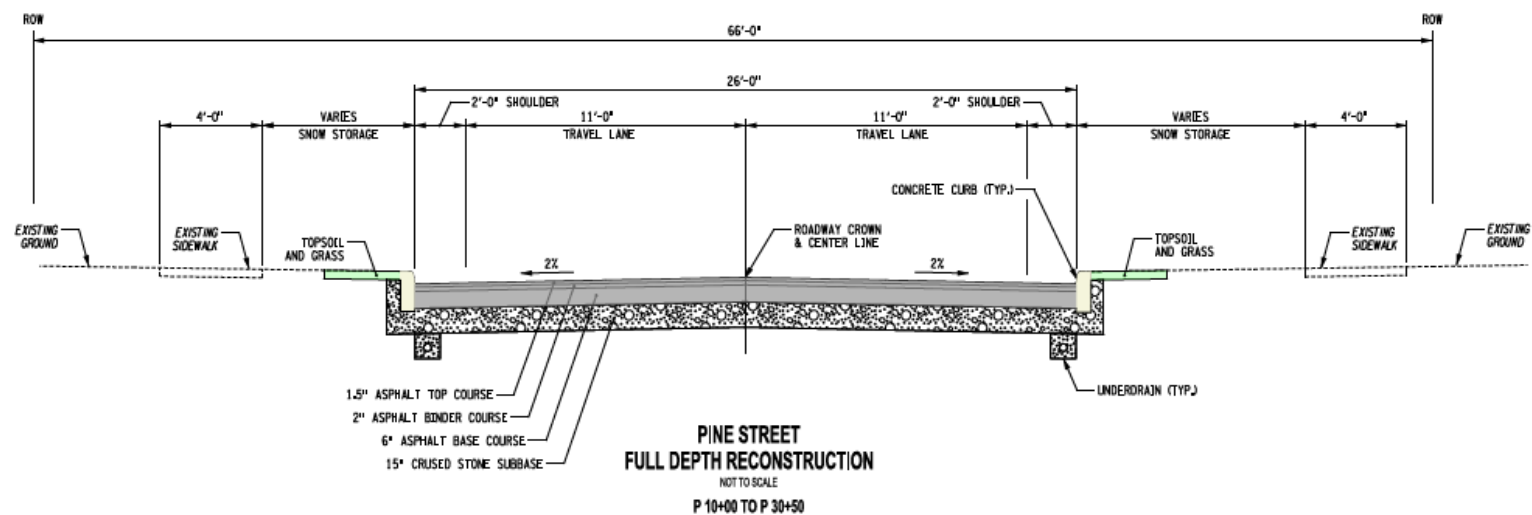
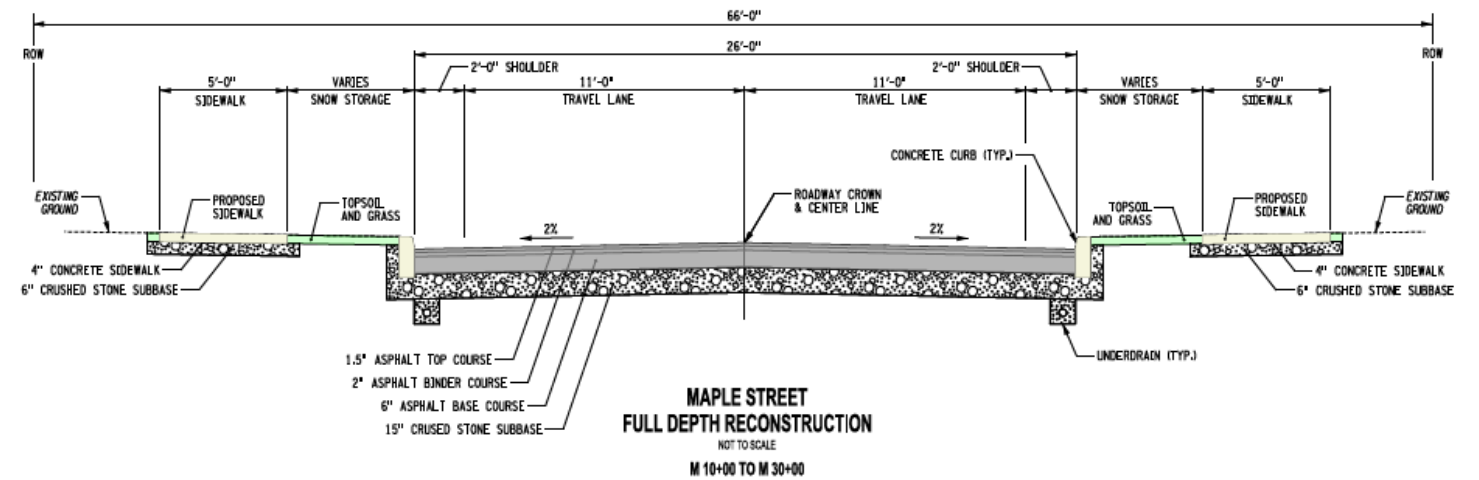

Maple Street and Pine Street

Erie County is addressing significant infrastructure needs in the Village of East Aurora on 0.38 miles of Maple Street (CR 241) from North Street to Main Street (NYS Route 20A), and on 0.38 miles of Pine Street from East Aurora-Porterville Road to Main Street.

Both streets are primarily residential in character through the project area. There are some businesses located at the southern extent of both where they intersect with Main Street. The two streets have very similar needs, and so Erie County determined that they will progress together through the preliminary design phase. They will be constructed in different years to

account for work zone traffic control needs during construction and as funding becomes available.

The projects will address poor conditions on both streets that include signs of pavement failure, and curbs on both streets that are almost buried by years of paving that added depth to the existing street bed. In some areas, curbs seem to be missing. Tree roots have interfered with some areas of sidewalk. Curb ramps for handicapped access do not meet current standards.

To improve safety, reliability and efficiency of both Maple Street and Pine Street, each 0.38-mile segment will be completely reconstructed,

replacing the pavement, drainage system, curbing, snow storage areas, driveway aprons, and sidewalk ramps. Additional improvements include new sidewalks on Maple Street, work on the Pine Street Bridge over Tannery Brook, updating signs and pavement markings, and utility pole relocations.

Motorists and residents can expect that there will be some traffic disruptions during the construction projects, including lane closures. Pedestrian traffic will be similarly disrupted from time to time. These disruptions will be kept to a minimum and will be communicated via a portable messaging board and updates on the

project website. Work zone operations will be coordinated with the Village, Erie County and New York State agencies.

Other important project details include:

- As these are residential streets, there will be no nighttime construction work.
- Potential impacts to street trees on each street have yet to be finalized. At a minimum, trees within the existing right-of-way will be trimmed to reduce dense canopy. Trees not to be removed will be protected during construction.
- No changes to the existing vehicular and pedestrian traffic patterns are anticipated.
