Project Description:

The Department has prepared a draft permit and has made a tentative determination, subject to public comment or other information, to approve a proposed discharge of up to 0.99 million gallons per day of process and non-contact cooling wastewater resulting from the manufacture of hydrogen gas (SIC Code 2813). The treatment system is in the design phase and the permittee is required to submit the final design to the Department for review and approval. The discharge will flow to the Massena Power Canal, a Class C waterbody.

The draft SPDES permit with fact sheet is available online at https://dec.ny.gov/fs/projects/draftpermits. The draft permit files are contained within regional folders and named by the SPDES number contained in this notice.

Pursuant to the requirements of Section 7(2) and Section 7(3) of the Climate Leadership and Community Protection Act (CLCPA), the Department has requested and received information regarding the project's consistency with the CLCPA.
